All relevant documents should be attested by a first class gazetted officer.
 (b) The contractors who have purchased the schedule must have the bank liquid money mentioned next to the project.
 (c) Income tax and VAT will be deducted from the bill as per the rules.
 (d) The Authority is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders without assigning any reason.
 (e) In case of any failure to comply with the terms of the contract, the concerned institution may be blacklisted along with forfeiture of the security deposit.
